



EDUCATIONAL TECHNOLOGY LEVEL I REQUIREMENT FOR MULTIPLE AND SINGLE SUBJECT CREDENTIALS

A teacher candidate can meet the Level I Educational Technology Requirement required for the Preliminary Multiple or Single Subject Credential in several ways:

1. Pass **both** subtests of the California Subject Examination for Teachers (CSET) Preliminary Educational Technology Exam:

Subtest I (Test Code: 133) – Basic Operations, Concepts and Issues of Computer Based Technology. Productivity Applications of Computer-Based Technology.

AND

Subtest II (Test Code: 134) – Teaching and Learning Applications of Computer-Based Technology.
